Michael Late Benedum Chapter of the AAPL raises over \$22,000 for West Virginia Veterans

Over 150 people attended the third annual MLBC Veterans Charity Clay Shoot in support of the West Virginia University College of Law Veterans Assistance Clinic, which provides free legal help to West Virginia Veterans. The Charity Clay Shoot, Dinner and Auction, which took place October 6, 2017 at Hunting Hills in Dilliner, Pennsylvania raised over \$22,000 through ticket sales, sponsorships and auction item sales, making it the most successful in the three-year history of the event.
