# legislative update

Greetings from the storm-soaked humid air of Appalachia where golf is plentiful and handicaps are changing. Recent changes to energy-related regulation in the tri-state area include a new Ohio House Bill expanding a sales tax exemption for property where oil and gas are produced and a Supreme Court ruling in West Virginia on mineral reservations.

#### Ohio

Ohio House Bill 430, which expands the sales tax exemption for property with oil and gas production, was signed into law by Governor Kasich on June 14 and will be effective on September 13, 2018. The bill amends Sections 3743.75, 5709.20, 5709.211, 5709.212, 5709.22, and 5739.02 of the Revised Code to modify language governing the sales of and use tax exemption for certain kinds of property used in the production of oil and gas.

"The new law gives Ohio's oil and gas industry clearer guidelines on what purchases qualify for a sales tax break, and arose out of industry concerns over tax audits. Previously, state law exempted the sale or use of tangible personal property used "directly" in production of oil in the and natural gas. This Act amends the law to remove the qualification that the property be directly used in the production of oil and gas. The Act also amends the regulatory definition of what is considered а production operation to exclude: operations. activities or equipment used in or associated with the exploration and production of any mineral resource other than oil and gas; storing, holding or blending solutions or chemicals used stimulation; well in preparing, installing or reclaiming foundations for drilling or pumping equipment or well stimulation material tanks: transporting, delivering or removing equipment to or from the well site or storing such equipment; and gathering operations occurring off the well site, including gathering pipelines, transporting hydrocarbon gas or liquids away from a crude oil or natural gas production facility." (Source AAPL Governmental Affairs Report June 18, 2018).

For Case # 2017-0448: Thomas Dundics, et al. v. Eric Petroleum Corporation, et al. in regard to landmen becoming real estate brokers, there has been no action taken since the last article. I will keep you updated on the latest developments.

On the lighter side about Ohio: the first traffic light was in Cleveland, the nation's first ambulance service was started in Cincinnati in 1865, Akron was the first city to use police cars in 1899, and Life Saver candy was invented in 1912.

#### West Virginia

The Supreme Court of Appeals in West Virginia ruled May 11, 2018 on mineral reservations in the case of Kupfer v. Chesapeake Appalachia, LLC (17-0527). The Court determined a deed with multiple parcels that "excepted and reserved from said parcels all the coal, oil, gas and other minerals" only applied to specific parcels named in the reservation but not to other parcels in the deed that did not contain reservation language.

Some famous folks hail from West Virginia: mathematician John F. Nash, Olympic gold medalist Mary Lou Retton, a football coach named Nick Saban, basketball legend Jerry West, a funny man named Don Knotts, a country singer named Brad Paisley, (you can see his sign if you're in Marshall County) and one of my favorites, fighter pilot Chuck Yeager who was the first to exceed the sound barrier.

#### Pennsylvania

There is good news for us in Pennsylvania. Senate Bill 835 regarding Landman and Pipeline Agent Registration was not amended as of the end of the general session. I will keep you apprised of anything that becomes proposed.

Pennsylvania trivia: The first zoo in America was the Philadelphia Zoo, and the first commercial radio station was KDKA in Pittsburgh. KDKA is still on the air today with the likes of their bad weatherman (guess who).

# director's report

#### AAPL Director's Report

On Wednesday, June 20, 2018 I attended the AAPL Quarterly Board Meeting in Denver, Colorado, which coincided with the AAPL Annual Meeting. This year's Annual Meeting was one of the best member attended meetings in recent years with nearly 700 members registered.

AAPL Headquarters

AAPL currently has 18 employees and 7 NAPE employees. AAPL recruited and hired Stacey Garvin as the new Director of Education and Member Services. Additionally, a new Member Services Coordinator and a new NAPE Creative Designer were hired.

2019 Annual Meeting will be held in Pittsburgh, PA! 2020 Annual Meeting will be held in Huntington Beach, CA.

AAPL will hold a renewal period from 7/1/2018 – 8/16/2018 for those companies wishing to remain "corporate partners." Corporate partners are those companies who have made a commitment to hire or engage only AAPL members. Corporate partners will receive website recognition as well as be recognized at the Annual Meeting in Pittsburgh in 2019.

The Committee Service application is now live online. If a member is interested in serving on a committee at the national level, this is the place to go. So far, 139 applications have been received.

The Advisory Landman Connection online application is finalized. Four Advisor applications have been received with another six Participant applications received.

#### NAPE

Final figures for 2018 NAPE Summit represent a strong finish with revenues being up by \$1,036,597 compared to 2017. AAPL's net distribution was \$2,282,019, a 20% increase from 2017. AAPL's management fee was \$641,600, a 9% increase from 2017.

AAPL's total net profit and management fee income from NAPE for the fiscal year was \$3,387,050, a 17% increase over the prior fiscal year.

2018 Summer NAPE is shaping up for a strong year, with total sponsorship revenue surpassing 2017 by over \$100,000 and registrations at 715, up from 426 in 2017. Two Harley Davidson motorcycles will be given away at the end of the show.

2019 NAPE Summit is planned to have an expanded job fair, a re-imagined ice breaker for enhanced networking, improved prospect Theaters, a special tea or luncheon in honor of women making a mark in the energy industry, a special recognition program in honor of young energy professionals and a sweepstakes drawing valued at \$40,000. Sponsorships for 2019 NAPE Summit are already at 99% of the total collected for 2018. Texas Railroad Commission, Ryan Sitton has been secured to present.

#### AAPL Educational Foundation, Inc.

The Foundation distributed the final round of assistance to the disaster relief recipients and retained approximately \$100,000 in a designated disaster relief fund for future unknown disasters.

In the near future the Certification Committee will be reaching out to MLBC to provide volunteer CPLs who would be interested in proctoring CPL/RPL exam retakes in our region. Rather than any CPL proctoring the retake, the exam taker will be required to have "an approved" proctor administer the retake.

#### Treasurer's Report

#### Statement of Financial Position -

As compared to March 31, 2017, total assets have increased from \$30,074,690 to \$32,644,891; a change of \$2,570,201 or 8.55%. This is primarily due to market activity related to the investment account as well as fewer operating fund withdrawals. Funds withdrawn from the investment account for FY 17-18 total \$573,654 and are solely related to Disaster Relief. Total liabilities as T compared to March 31, 2017 have increased from  $\frac{1}{90}$ \$1,426,826 to \$1,612,554; a change of \$185,728 or 13.02%. This is primarily related to membership dues rates increasing July 1, 2017 and timing of accounts payable and accrued expenses.

#### Statement of Activities -

Revenues (exclusive of investment revenue) compared to March 31, 2017 have increased from \$2,439,582 to \$2,919,300, a change of \$479,717 or 19.66%. The increase in revenue is due to the increase in membership dues prices, reinstatement of recertification fees, the increase in education seminar prices, addition of income from Contract Center, and the addition of rental income from NAPE Expo. Member dues revenues increased \$256,530 (22.94% increase from \$455,777 to \$572,702). The additions of recertification fees of \$52,725, Contract Center forms income of \$75,597 and rental income from NAPE Expo of \$69,750 all contributed to the overall increase in revenue. There was a decreate in revenue to AAPL from NAPE when compared to prior year for approximately \$89,000.

Expenses have increased 3.15% from \$4,905,434 to \$5,060,017, a change of \$154,584. The increase in expenses is due to the \$573,654 disaster relief contributions AAPL made to the AAPL Educational Foundation. When this one-time expense is excluded, expenses decreased 8.54% overall. The decrease is largely due to the elimination of government lobbying expenses within governmental programs (67.18% decrease from \$118,109 to \$38,769) and a reduction in salaries and benefits of 21.31% (from \$2,533,960 to \$1,993,963) due to moving seven employees to NAPE Expo.

Statement of Investment Accounts -

Investments as of March 31, 2018 total \$26,878,357, an increase of \$2,422,980 or 10.13% as compared to the same period last year. The change has been the result of unrealized and realized gains in the AAPL investment account as well as fewer operating fund withdrawals. Funds withdrawn from the investment account for FY 17-18 total \$573,654 as of March 31, 2018 and are solely related to Disaster Relief.

#### Education

AAPL held 16 seminars in Q4. Additionally, planned programs and new seminar development for the following

topics is being implemented:

- Fundamentals of Field Land Practices
- Structuring a Deal Petroleum Economics
- Negotiation Strategy & Technique
- Held-By-Production
- Due Diligence

#### **Governmental Affairs and Forms**

In Q1 2018 AAPL provided an amicus brief letter for a case before the Texas Supreme Court as well as an amicus brief process for the ongoing Dundics case before the Ohio Supreme Court. It appears the courts are viewing the case as contractual rather than licensing. AAPL is watching.

The Pennsylvania licensing bill has been tabled in committee. AAPL is watching.

AAPL has implemented a new Voter Voice platform to mobilize members to interact with their representatives on important legislative issues.

#### Landman Scholarship Trust

For the first time, AAPL was able to provide press releases for the scholarship winners to 31 student's hometown newspapers. In total, 56 students were presented with scholarships totaling \$240,000 from the 12 programs that were eligible to participate in the process.

**KP:** 12 years, I have worked in Texas, West Virginia, Pennsylvania & Ohio. I am a member of the AAPL, Fort Worth Association of Professional Landmen. In the past I was a member of Young Professionals in Energy and Generation Morgantown but not currently an active participating member.

**MLBC:** Tell us about your first position in the industry.

KP: I researched title in Hood County, Texas. The picturesque courthouse is situated on an old downtown square with a book store, coffee shop, and one of the best BBQ restaurants in the State. I would pull a stack of documents from the musky deed records room then retreat to the coffee shop to deed plot, map, and flowchart before returning for additional research. You cannot effectively acquire or develop anything until you know who owns it.

**MLBC:** What areas of the industry do you have experience in?

**KP:** Project management; lease and mineral acquisition & divesture; due diligence; title abstracting & review; title curative; easement and ROW; mapping; lease analysis & modification; negotiation; and, accounting & payroll.

**MLBC:** Do you have a mentor in the industry? Can you provide details?

KP: Yes, my father, Fred Pierson, is a mentor to me in the industry. I'm a second generation Landman. My Dad first introduced me to the industry at a young age so I could at least explain to my friends what he does for a living. "Landman" was not a typical job on career day. This is where my intrigue and passion for the industry began. My Dad retired a few years ago after working for the same company (through two mergers & acquisitions) for 35+ years. He started his career in domestic oil and gas, then worked as an international landman negotiating agreements with foreign governments, and eventually retired working domestic projects as shale development revolutionized the industry. Although we did not work together directly, this was an additional bond we shared allowing us to discuss current industry topics, ins & outs of the business, share ideas, and vent about our daily stresses. Bryson Kuba is also an influential person in my career and life. He believed in me when I was new to the industry and provided me the opportunity to learn. He guided me, taught me, and took the time to explain "the right way" of doing things almost like an unofficial apprenticeship. I would not the experience, have objectivity, or exposure without Bryson taking an interest in my development as a landman and person. I will always be grateful for the experience and opportunities I've been provided from others.

**MLBC:** Do you serve the MLBC, AAPL, or any other organizations in an executive capacity and/or serve as a committee chair? Are you a member of any committees?

**KP:** Yes, I'm new to the

Executive Committee as a Director. I'm currently the Scholarship Committee Chairman, University Liaison, and serve on the Mentorship Committee. I also serve on committees at my golf club and enjoy helping out with other organizations in an official or unofficial capacity as needs arise.

MLBC: According to Article IV, Item #5 of the Bylaws of the MLBC, one of the organizational purposes of MLBC the chapter is "Providing members with opportunities for community service." Have you ever initiated or participated in events or service projects within the community that achieve this purpose?

KP: My current focus is MLBC the Student Scholarship and my new role as a Director. The student scholarship is especially important to me because I was awarded a student scholarship by the Fort Worth Association of Professional Landmen (FWAPL) while in college and know first hand the difference the scholarship makes with these students.
