The MLBC Awards consist of the following:

Current MLBC officers are excluded from nomination.

DIRECTOR'S REPORT



n March 11-12, 2017, I attended the Quarterly Board of Directors meeting in Santa Barbara, California.

During my free time, on a clear and sunny afternoon, I visited the marvelous County Courthouse. Perhaps this qualifies me as a courthouse nerd. Be that as it may, I took quite a few pictures, including the two attached. The first one shows the main entrance. The second is a view of the city taken from the 5th floor tower. Following is my summary of the Board meeting.

Membership and Certification:

As of February 20, 2017 Total Membership count stood at **15,576**. Active Members: 13,354; Associate Members: 1,469; Student Members: 605.

There are 2,889 CPLs; 2,255 RPLs; 421 RLs; and 30 Retired CPLs, bringing the total of land professional designees to **5,645**.

~Note: The Certification Committee continues to regularly review applications. Currently there are several MLBC members who have applied for certification; 4 being RPL Applicants and 6 being CPL Applicants.

As AAPL President Pamela D. Feist, CPL stated, "Certification is a valuable membership benefit that demonstrates to peers and employers a member's level of competency and commitment to further his or her professional skills and knowledge."

AAPL 63rd Annual Meeting - Seattle, June 21-24, 2017 - The host hotel located in the Emerald City is the Sheraton Seattle.

~Note that rooms are limited and reserved for registered Annual Meeting attendees.

~Earn up to 15 CEUs, including 1.5 ethics credits.

~Hot Play Happy Hour Socials is new this year and will include **Marcellus/Utica**, Eagle Ford, Permian, Bakken, Scoop/Stack and Mississippi/Alabama/Georgia/ Louisiana/Golf of Mexico/East Texas. These socials will be held at local hot spots within walking distance of the host hotel.

~Landman Bash - The venue for this always popular event is the Museum of Pop Culture (MoPOP).

Effective for the 2017 year (July, 2017):

~AAPL Dues for Active and Associate Members will be **\$125.00**. The motion included that an additional adjustment to \$150.00 will be made in 3 years, absent Board vote to the contrary. Multi-year dues, i.e. 3 and 5 year, increase proportionately.

DIRECTOR'S REPORT CONTINUED

Here are some facts supporting the decision for the increase in dues:

- With the dues increase, the budget will be balanced for the first time in several years after operating over \$4,000,000 in the red for the past four years.
- The last dues increase occurred 14 years ago in 2003 when dues were increased from \$75.00 to \$100. This is the longest period between dues increases in AAPL history.

The purchasing power of \$100.00 in 2003 was equal to \$129.77 in 2016.

With NAPE revenues down significantly, services would have to be cut without an increase in dues.

~Note: The Certification Fee and Re-Certification Fee is \$100.00

Treasurer's Report (for the period ending December 31, 2016):

~Balance Sheet: As compared to December 31, 2015 total assets decreased from \$30,736,492, to \$30,069,402 a change of \$667,090 or 2.17%. Total liabilities have decreased from \$2,926,302 to \$1,448,113; a change of \$1,478,189 or 50.51%. This was due primarily to the repayment of the \$1,000,000 building note payable, and also a decrease of \$244,401 loan; a result of uncarned long term 3 and 5 year dues.

~Revenues (exclusive of investment revenue) decreased 20.03% from \$2,151,256 to \$1,720,342. The decrease in revenue is due in part to a reduction in NAPE distributions and management fees of \$264,574 (33.86% from \$781,487 to \$516,913) and lower attendance at Summer NAPE. Educational seminar fees decreased \$66,828 (18.12% reduction from \$368,909 to \$302,081) as a result of a decline in CPL review attendance due to a rule change.

~Expenses have decreased 21.66% from \$4,033,918 to \$3,160,165. The decrease in expenses is primarily a result of cost reductions related to food/beverage, speaker expense/fees, and virtual attendance for seminars (64.64% reduction from \$507,155 to \$179,315), a reduction in costs from eliminating the Landman 2 publication (25.17% reduction from \$292,223 to \$218,665) and decrease in general and administrative expenses (22.23% reduction from \$942,127 to \$732,684).

~Investments Accounts: As of December 31, 2016 investments are \$23,877,276 a decrease of \$131,230 or .55% as compared to the same period last year. The decrease has been the result of transfers of cash of \$2,430,000 since December 31, 2015to the AAPL operating account; however this has been partially offset due to unrealized and realized gains in the AAPL investment account of \$2,298,770.

~Note: The Fiscal Year 2017-18 Proposed Budget was voted on and passed unanimously.

NAPE

 \sim <u>Summer NAPE 2016</u> - AAPL received \$375,562 as its distribution and \$141,351 as its distribution fee. The amounts were less than 2015 due to fewer attendees.

~<u>NAPE Summit 2017</u> - Attendance numbers exceeded budget expectations by 24%!

 \sim <u>NAPE Expo Charities Fund</u> - A new legal entity has been filed with the Secretary of State's Office to form a public charity. The purpose is to allow donors to have more flexibility to direct gifts.

~Note: As mentioned in my previous report, regional NAPE events have been suspended for now. Plans however, for Summer NAPE August 16-17 are underway. In addition to Hot Play Happy Hour Socials, NAPE's Lease Exchange Theatre will be the place for not only selling prospects, but also trading leases. Go to <u>www.NAPEexpo.com/</u>

Dundics Decision:

Many of you are familiar with the recent Dundics decision in **Ohio** regarding landman licensing under the Real Estate statute. This was discussed before, during, and after the board meeting and is a hot topic on *Landnews*. AAPL is preparing a Support Brief to be filed with the Ohio Supreme Court in hopes the Court will agree to review the appellate decision. AAPL would like to see as many briefs as possible filed to convince the Court to hear the case.

Public Lands and Access:

The Bureau of Land Management has announced based on a review of the Environmental Assessment (EA) compiled over the past several months, oil & gas leasing of minerals located in Monroe, Noble and Washington Counties, Ohio, will have "No Significant Impact" on the Wayne National Forest. The EA has not been issued and will not be issued until public comments have been accepted for the draft.

The PLA committee noted that the Trump Administration and Congress are in the process of rescinding many policies and rules through the use of the Congressional Review Act.

West Virginia University: **College of Law** Veterans Advocacy Demonstrating its commitment to veterans across the state, the West Virginia University College of Law has expanded its Veterans Assistance Project (VAP) from a practice area within the General Clinic to a standalone clinic, the WVU Veterans Advocacy Clinic (VAC), directed by Associate Professor Jennifer Oliva, a graduate of the United States Military Academy and an Army veteran.

There are approximately 170,000 veterans that currently reside in the state of West Virginia, many with acute and unique legal needs related to their military service or return to civilian life. In addition, students will represent local and national organizations in non-litigation matters relating to the legal needs of veterans, including regulatory and legislative reform efforts, media advocacy, and strategic planning. 
