#### **PROPER PLANNING PREVENTS ... WELL, YOU KNOW THE REST**

Things are going well in our industry. Capex budgets are growing, people are back to work, and it has even become difficult to fill open positions. The outlook is bright and it appears it will stay that way for a while. But, will it? If you have been in the natural resources industry for more than a couple years, you no doubt have seen or even experienced the cyclical ups and downs, the booms and busts, the highs and the lows. Whether we think it will be short-lived or longlasting, the truth of the matter is that we can never be sure. To that end, I would propose that, instead of trying to decide whether to be pessimistic or optimistic about the situation, perhaps the wise course is to be opportunistic with an eye on the long game.

What do I mean?

I think Benjamin Franklin said it best: "By failing to prepare, you are preparing to fail." The time to prepare is when things are going well – when you have the resources and opportunity to put yourself in a better position for the hard times that will inevitably come. If the hard times come sooner, you will be prepared to weather the storm. If hard times come later, you may find that it does not even impact you much at all. If the hard times never come (unlikely as that is), you can retire early and sip margaritas poolside. Whatever the scenario, it is a win-win situation that leads to a less stressful, more enjoyable life. That is something we all want, right?

Unfortunately, all too often we find ourselves making short-term decisions that we think will make life less stressful or more fun, but end up leaving us unprepared and maybe a little regretful. For example, if you find yourself making more money or in line for a promotion, it is easy to get sucked into the temptation to spend those extra funds. Perhaps you have asked yourself questions like: Should I get a new truck? Should I look for a bigger house or a house in a better neighborhood? Should I take that Hawaii vacation I've always wanted to take? Maybe a boat or a jet ski would be fun?" The struggle is real, right? To help you battle those kinds of temptations, here are some simple suggestions on how we can be wise and use this as an opportunity to prepare for the future:

- If you have more money coming in or you expect to make more, set some financial goals and make a budget that uses the additional income to achieve those goals.
- Begin building an emergency fund. Saving at least 3 to 6 months of living expenses is recommended.
- Saving money consistently can be difficult. Setting up automatic withdrawals or other automatic mechanisms can be helpful.

- If you have children, do they plan to attend college? It may be wise to start setting aside income to help them pay for it. Even if you don't pay for everything, helping out with the cost of books or living arrangements may be incredibly helpful for them.
- Rather than take on new debt (like a new house, car, or boat), build more equity by paying down current debt. If you later need to downsize, it will be that much easier to do so; or, you can later leverage that equity to refinance and reduce your monthly expenses. Either way, you're in a better position to react should something happen.
- Plan for major purchases. For example, set money aside for major home repairs you know are coming in the future, including the purchase of any large-ticket appliances you know will need replaced.
- Increase the amount you regularly contribute to retirement funds. This can help you retire more comfortably or even earlier if things go well. Worst case scenario, it can at least keep you on track if you later become unemployed or make less money for a time.
- Consider upping or adding insurance coverage to important items. This will make future losses much easier to bear. An umbrella insurance policy is typically quite inexpensive but can be a lifesaver in some situations.
- Even if you have good credit, your credit may continue to improve even further. Look for opportunities to refinance and, potentially, gain better terms on medium and long-term debt.
- If you have the ability, consider creating an investment portfolio that isn't tied to the natural resources industry. That way, should something happen in your current industry, you may have additional funds available that won't plummet along with this industry's commodity prices.

- Take the time to build your professional network, making efforts to stay in touch with those outside the core of the industry. It never hurts to know someone you can reach out to when hard times hit. MLBC events are a great way to stay in touch and make new contacts.
- Get expert financial advice (and not from some nerdy landman who writes newsletter articles) to help you make wise choices with additional disposable income.

Of course, this list barely scratches the surface and won't apply to every person or financial situation. Yet, the point is the same no matter where you are at financially. We don't know what the future holds. The smartest thing we can do is plan for the worst and hope for the best. This is especially true for all our contract landmen out there. Regardless of where you may fit into the big picture, we would all benefit from viewing the current time as an opportunity to prepare ourselves for the future.

# Marietta College Energy & Land Management Program





My name is Bailey Miller. I am in my junior year at Marietta College as a Land and Energy Management major, with a minor in Legal Studies and pursuing an Engineering Leadership Certificate through the Marietta College McDonough Leadership Program. I am also the President of our campus chapter of AAPL, which is the Marietta College Land Association. Our student organization gets students involved in the energy industry through educational meetings and events as well as networking events, such as the September 8th MLBC event at the Galley, held in Marietta, which active members of MCLA attend. We are also hoping to hold campus events this year to get students pursuing a career in the energy industry more involved with each other and on campus as well.

This summer, I had the opportunity to attend the AAPL 68th Annual Meeting in Chicago, Illinois. I represented Marietta College as I served on the Student Leadership Committee with students from other schools with AAPL accredited programs pertaining to energy and land management During the Student Leadership Committee meeting at the conference, I had the opportunity to collaborate and share ideas with other students for our campus chapter organizations. The ideas and connections that I got to take away from the meeting will help me further my educational and career goals.

This summer I also had the exciting opportunity to get started in the industry as an intern with Atwell, LLC. I primarily worked with project managers on projects that Atwell was working on for utility companies such as Novis Renewables, Commonwealth Edison, DTE Energy, and NextEra. These are all utility companies that hired Atwell to take care of their projects. I learned in much more depth about different kinds of agreements and all aspects of project management as a whole. I performed tasks such as evaluating and organizing documents such as introductory packages for landowners and revising agent notes, as well as analyzing maps and land documents/agreements to organize a project to lease for renewable energy projects.



I also performed other basic interdepartmental tasks and research such as due-diligence and project management oriented tasks as needed. I provided input and participated in project kick-offs, developments and close out processes while seeing the complete project life cycle throughout its duration. I had the opportunity to participate in a mentorship program to receive insight and assistance on technical and work-related tasks. I also analyzed projects and project spreadsheets to provide updates and reviews for project managers, as well as examined legal documents to help determine terms of ownership, leasing terms and rights for property and ownership. Lastly, I participated and sat-in on administrative meetings to gain insight on daily tasks for project managers and the administration team altogether. I am now taking my knowledge of the legal field and education of it itself from my minor in Legal Studies and using it toward my internship that I am currently at working at the office of Attorney Nancy E Brum in Marietta, Ohio. I am hoping to expand my legal knowledge and use it toward my goal of attending law school to become an oil and gas attorney myself prior to graduation from Marietta College. As of now, I am being introduced to real estate and more extensive property law while conducting detailed research on title and deeds as well as ownership within wills, which my prior internship prepared me well for. I hope to continue expanding my knowledge of the energy industry and legal field as well through these opportunities.

#### LUNCHEON AND ROUNDTABLE SESSION MARIETTA COLLEGE - SEPTEMBER 8, 2022

Marietta College

On September 8th MLBC representatives attended a luncheon with Marietta College students in the Energy and Land Management Program. In attendance for MLBC were: Marc Acree, Stacy Tichy, John Catsonis, Danny Cooper and Chuck Saffer. Approximately 15 students attended including two petroleum engineering majors. The luncheon was organized by the program director, Professor Tina Thomas. The students were appreciative of having a taco lunch. The discussion focused mainly on career building and networking. Each of the MLBC participants discussed their current jobs and responsibilities. Also discussed was the need to 'make friends' and 'remain professional' when working in courthouses as having personal connections with courthouse employees can be very helpful. Marc Acree stressed the need to protect confidential information at all times when working in a public location. During the discussion both John Catsonis and Danny Cooper recounted how they personally got their respective starts in the industry. All participants agreed that having abstracting knowledge and experience is of great benefit in all types of land work. The general consensus was that abstracting is currently probably the most in demand position for new hires. Also discussed was the need for prospective land professionals to be cognizant of opportunities outside of traditional exploration companies and brokerages. A few potential alternatives discussed were renewables, mineral buyers and conservation/environmental mitigation groups. Students were advised that they are welcome to attend MLBC events. It was mentioned that MLBC attendees vary based on event location so if possible students should try to attend events in West Virginia or Pennsylvania.

# LEGISLATIVE & REGULATORY UPDATE

Welcome back to the real world! Now that summer is over, and Russian gas is being abandoned by many around the world, the oil and gas industry, and particularly the operators and land professionals in the Appalachian Basin, find themselves with more to do than ever before. There was not a lot of activity over the summer, but a few interesting developments arose.

*SWN Production Company v. Kellam*, 875 S.E.2d 216 (W. Va. 2022). Certified question to W. Va. Supreme Court from federal district court for the Northern District of West Virginia. Primarily, the Supreme Court was asked whether the 2006 case *Estate of Tawney v. Columbia Natural Resources* remained good law, and, if so, how to apply the requirements regarding deduction and calculation of royalties contained in that lease. After a lengthy discussion of the history behind royalty litigation in West Virginia and comparing the circumstances of *Tawney to Leggett v. EQT Production Co.*, 239 W. Va. 264 (2017), the Court concluded that Tawney remains good law and is applicable to contractually created royalty provisions, while *Leggett* applies to statutorily created royalties.

Senterra Limited v. Winland, 2022-Ohio-2521. Marketable Title Act case. In a unique twist, the surface owner attempted to utilize the Duhig rule (a Texas case regarding repeated, identical reservations of oil and gas interests) to indicate that a ¼ oil and gas reservation was void at its inception, and therefore should be vested with the surface owners. The court disagreed, pointing to the unbroken chain of title of the severed mineral owners effectively preserving the reserved oil and gas interest. The court further found that reliance upon *Duhig* would not resolve the issue in favor of the surface owner in any case and found in favor of the severed mineral owner.

In addition to the above cases, the new West Virginia statutory pooling statute became active as of June 30, 2022 (W. Va. Code §22C-9-7a). This allows oil and gas operators to bring unleased interests into an oil and production unit without landowner consent under certain circumstances. As a threshold issue, at least 75% of the net acreage in a unit must be under lease/control of oil and gas operators, and 55% of the working interest must be vested in the operator making the petition for a statutory unit. Operators can effectively establish joint operations with other, minority operators using the statute. However, the applying operator must first go through an extensive application process that includes (among other things) a significant investment in time and effort to compile title for the entire proposed unit. The application process must be heard by the Oil and Gas Conservation Commission in Charleston and is subject to extensive accounting oversight before approval will be given. As of the date of this writing, we understand that only one application has been made and no approvals have yet been given.

Also, effective June 30, 2022, West Virginia removed the prior requirement under the Cotenancy Modernization and Majority Protection Act (W. Va. Code §37B-1-1, et seq.) that, as a threshold matter, there needed to be at least 7 "royalty owners" before the act could be utilized. The only threshold matter as to whether the Act applies now is whether the operator seeking protection under the Act has at least 75% of the oil and gas leased or otherwise controlled. Finally, West Virginia instituted new reporting requirements for well production and payments for royalty owners (W. Va. Code §37C-1-1, et seq.). Failure to make timely payments and reports under this new act will result in fines against Operators on a percentage basis, calculated as prime rate plus 2% in interest charges against the amount unpaid.

# **Member Spotlight: Justin Nixon**

#### Tell us a little about yourself.

For a little over 30 years, my mother ran a restaurant for farmers every Saturday at the stock yards in Weston, WV. I spent quite a few Saturdays learning to cook home style food, training my ear to keep up with the auctioneer, and getting to know the people that put food on our table. My mother wore her heart on her sleeve – one of those "would give you the shirt off your back" types – and she could to talk to anyone about anything. So, from an early age, I learned how to talk to people and really get to know their story, to care about them.

Later, when I became landman, I quickly realized that this ability to talk to people was a pretty handy skill to have. In fact, it didn't feel so much like a job as it did just getting to know the landowners I was negotiating with. I've always enjoyed that part of my job. Whether it's dealing with farmers, attorneys, or my co-workers (who, by the way, are some very talented folks), I just find myself being thankful that I found work that I enjoy getting up for each day.

#### Who are you currently employed or contracted with?

I'm currently serving as Title Attorney for Northeast Natural Energy LLC out of the Morgantown, WV, office.

### How long have you worked in the oil and gas industry? And what states do you have experience? And tell us about any other land organization you belong.

I entered the industry in 2009 and, since that time, primarily worked in West Virginia and Pennsylvania. I'm an active member of AAPL (holding a CPL), sit on the board of the MLBC Foundation, and I'm an active member of the EMLF.

#### Tell us about your first position in the industry.

During my last semester of law school, I knew I wanted to work in the oil and gas industry. So, I was fortunate enough to find a part-time position with Claire Seargent Walls assisting with the preparation of portions of title opinions. It was a good experience and, without a doubt, helped me a great deal in my next role as a contract landman for Mason Dixon Energy, LLC curing title in the Victory Prospect in Marshall and Wetzel counties, West Virginia. Those were the "glory days" for me in the shale revolution - long days, tough title, but all the Quinet's your meal per diem could afford.

#### What areas of the industry do you have experience in?

After the title opinion prep, I gained experience in title curative, leasing, surface (padsite and right of way), division orders, and have a working knowledge in various other land-appurtenant areas like environmental and regulatory/permitting.

#### Do you have a mentor in the industry? Can you provide details?

I've been fortunate to work for, in one way or another, a number of truly great landmen. Aaron Yost, Lhag and Asa Bowers, Vidal Quevedo . . . I've learned a great deal from all of them. But, just the same, I've learned a great deal – and have grown as a landman – from so many other wonderful people around me. 




